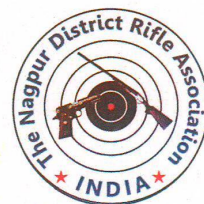

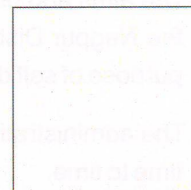

IMPORTANT INFORMATION

1. The aims and objects of the Association are to encourage the art and science of marksmanship throughout the Nagpur District particularly among the Civilian population as a healthy sport which will also serve the purpose of self defence.
2. The administration and management of the Association is carried on by a body elected for the purpose from time to time.
3. The classes of Membership are as follows :

Enrolment Fees	: Rs. 1000/-
Junior Dependant Members	: Paying Rs. 8000/- in lump-sum. (Age limit between 12 yrs till 18 yrs.)
Life - Members	: Paying 15000/- in lump - sum.
Patron Members	: Paying Rs. 25000/- in lump - sum.
Annual Renewal Fees	: Rs. 500/- (Every Year to be paid by all the life member)

4. Payments made by Cheque / Demand Draft / Pay Orders to be made in the name : **The Nagpur District Rifle Association.**
5. All Correspondence will be made in the name of the **Gen. Secretary, The Nagpur District Rifle Association**, Plot No. 220, Ravi Nagar Square, Amravati Road, Nagpur - 440 013.
6. A member shall cease to be member of the N.D.R.A. on acceptance of his resignation or having been found guilty of an offence in the opinion of the Governing Body or a criminal misconduct. The findings of the Executive Committee will be final.
7. Please note that the proposal should be from a member of the Association and it should be seconded by another member of this Association.
8. The endorsement is necessary by any member of the Executive Committee.
9. However the decision of the Executive Committee shall be final regarding admission of new member's.
